Through the LEGAL DEFENCE AND FAMILY SUPPORT FUND (FUND), JCIRA was able to provide 397 direct financial support payments to approximately 300 immigrant families who reside in Jefferson or Clallam counties or in the Northwest Detention Center in Tacoma. Serving immigrant families through this FUND since 2017, the need for support exploded in April with the devastating effects of the COVID epidemic. Immigrant family incomes were severely cut, and government supports for COVID needs were not generally available to immigrants. The basic needs for adequate housing and food severely threatened many of our immigrant neighbors. With generous support from the Jefferson County Foundation, and individual donors, we were able to provide \$200,300 in financial assistance in 2020.

JCIRA provided financial and other types of non-financial support to two special needs individuals applying for asylum and staying in our community. Through outreach we secured housing and needed transportation, and provided direct financial assistance for basic needs such as clothing, medical needs, transportation to court hearings, telephone service, and assistance to their housing hosts. Both asylum seekers were able to obtain work permits while awaiting their hearings. JCIRA invested \$4,651 in this program in 2020.

JCIRA assumed financial responsibility for the local English as a Second Language course previously conducted by the YMCA. JCIRA secured the services of the previous teacher to conduct virtual classes for approximately 10-15 students in 2020 and invested \$2,844 in professional services of the instructor.
